During the management of the epidemiological emergency COVID 19, the effort implemented by the Company to maintain the safety levels of its employees / collaborators and to maintain the requirements expressed by the SA8000 standard, especially in relation to possible discrimination and forced labor, is evident from the numerous communications and security PPE acquisition actions prepared at the HEADQUARTERS and at the branches.

- constant monitoring of compliance with SA8000 requirements;
- careful and timely analysis and risk assessment to highlight critical areas with greater potential for non-compliance;
